Sanitary Service Company (SSC) is pleased to offer you the option of paying your waste and recycling collection bill through automatic withdrawal from your United States checking or savings account.

Our Auto Pay Plan is the easy, convenient and environmentally-friendly way to pay your waste and recycling collection bill. Just complete and sign the Authorization Form below, detach it and return it to SSC along with a **VOIDED CHECK** or **SAVINGS WITHDRAWAL SLIP** from the account you want your collection bill payment taken from. **It is important to send either a voided check or savings withdrawal slip and NOT a deposit slip. Deposit slips DO NOT contain all the necessary bank coding information.**

Please continue to pay your bill as usual until your collection bill indicates the amount will be deducted from your bank account. Even though your bill will be paid automatically, you will still receive a statement from us. It will detail your service, how much is owed and the date when funds will be withdrawn from your account. There is no charge to use the Auto Pay Plan.

If for some reason you want to cancel the Auto Pay Plan, simply notify us in writing thirty (30) days before your account is scheduled to be debited (the due date on your bill). If you want to change the account you use for the Auto Pay Plan, or if you change banks, please notify us as soon as possible and we will send you a new Authorization Form to complete.
